ACCOMMODATION UNIVERSITY YEAR 2024/2025

I. Accommodation request

- I.1. Between **17.06.2024** and **08.09.2024**, foreign students of Constanța Maritime University, enrolled in full time study programmes, can request accommodation in the university dormitories for the 2024/2025 academic year.
- I.2. The period is extended for students who are admitted to the 1st year of study 2024/2025, following the admission session in September 2024.
- I.3. The request is made by filling in the CMU website the Request for accommodation form.
- I.4. Accommodation requests submitted **after the deadline** will be considered **within the limits of the remaining available places**, after the accommodations have been made.
- I.5. After completing the form electronically, students who fall under the performance criteria, the social criteria, the medical criteria or the volunteer criteria priority beneficiaries of accommodation will send to the e-mail address camine@cmu-edu.eu: photocopies of the requested documents for granting accommodation priority:

A. Performance criterion			
1.	Students with academic performance	Certificate issued by the Faculty, attesting to the fact that they have averages of at least 8.50 in the previous years of study	
2.	Students with achievements in scientific and technical extracurricular activities	Copies of the diplomas obtained as students in scientific and technical extracurricular activities with a maximum of 12 months prior to submitting the accommodation request.	
3.	Students with cultural-artistic performances	Copies of diplomas obtained at national and/or international competitions with a maximum of 12 months prior to submitting the accommodation request.	
B. Volunteering activities criterion			
1.	Academic, cultural and sports activities carried out by CMU	Document presenting the activities carried out, signed by a teaching staff of the CMU - responsible for their development. The activities must be carried out during the current academic year. The original document is submitted at the accommodation.	

2.	Administrative activities carried out within the CMU	Document presenting the activities carried out, which will include at least 5 activities and will be signed by an employee of the CMU, responsible for their development. The document must be approved by the head of the compartment/department. The activities must be carried out during the current academic year. The original document is submitted at the accommodation.
3.	Academic, cultural, sports, social activities carried out by Student League	Document presenting the activities carried out, which will include at least 5 activities, from the current academic year, signed by the Student League President, or a certificate signed by the Student League President certifying the occupation of a position within the organization for a period of at least 3 months from the current academic year. The original document is submitted at the accommodation.
4.	Volunteering activities carried out by any public or private legal entity, non-profit, or social enterprise or social insertion enterprise, which organizes and administers volunteering activities in accordance with Law no. 78/2014 on the regulation of volunteering activities in Romania with subsequent amendments and additions.	Certificate signed by the head of the organization. The original document is submitted at the accommodation.

II. Distribution of accommodation places

- II.1. The distribution list is published according to the structure of the academic year, but until 25.09.2024.
- II.2. The allocation of accommodation places is made taking into account:
- the accommodation capacity of each dormitory,
- operating expenses differentiated for each dormitory,
- the enrollment number of foreign students on scholarships, of foreign students on their own account in lei/currency,
- Students included in the performance/social/medical/volunteer criterion.
