Application to take part in the competition, registered by the closing date, signed and dated by the candidate, including a sworn statement (in original) concerning the accuracy of the information provided in the application file (in original) -Annex 2. The application is accompanied by the consent to the processing of personal data - Annex 2.1
2. A proposal for the development of the candidate's academic career in terms of both teaching and scientific research activities (maximum 10 pages). This document is one of the main selection criteria;
3. Curriculum vitae of the candidate (in original, signed on each page). and in ELECTRONIC PDF format, WITHOUT SIGN- under Personal data to include name, surname and e-mail address. Annex 3 (Europass model) Curriculum vitae includes: a) information on studies and diplomas obtained; b) information on professional experience and relevant jobs; c) information on research and development projects that the applicant has led as project director or has been a member of, indicating for each source of funding, the volume of funding and the main publications or patents resulting; d) information on awards or other recognition of the applicant's scientific work.
4. Verification sheet on the fulfillment of the specific standards of the post, completed by the candidate (in original, signed on each page). The application form in ELECTRONIC PDF format, WITHOUT SIGNATURE. The candidate assumes responsibility that the letter and electronic formats contain the same information- Annex 4.1, 4.2. For the posts of lecturer and university professor the completed form according to the specific requirements of OMENCȘ 6129 of 2016 on the minimum standards for conferring teaching titles

The applicant assumes responsibility that the letter and electronic formats contain the same information - Annex 5. The candidate's complete list of papers will be structured as follows: (a) a list of the maximum of 10 works considered by the candidate to be the most relevant to his/her own professional achievements in the field of the disciplines of the post for which he/she is applying and which are included in electronic format in the file and may be found in the other categories of works; (b) doctoral thesis(s); (c) patents and other industrial property titles; (d) books and chapters in books; (e) full-length articles/studies published in journals of the main international scientific journals; (f) full-length publications in proceedings of the main international conferences of specialized journals; (g) other scientific papers and contributions
6. Documents relating to the possession of the doctor's degree: a certified copy of the original doctor's degree or, if the original doctor's degree is not recognized in Romania, the certificate of its recognition or equivalence, in certified copy
7. The abstract of the doctoral thesis - in Romanian and in an international language
8. Simple copies of other diplomas certifying the candidate's studies (baccalaureate, bachelor's, master's, master's / advanced studies and their transcripts / supplements) or, if the original diplomas are not recognized in Romania, the certificates of recognition or equivalence; copies of other diplomas certifying the candidate's studies. II WORK MAP (file cover Annex 1)

A maximum of 10 publications, patents or other works of the candidate, in printed and electronic format, selected by the candidate and considered to be the most relevant to his/her professional achievements; if one or more publications are not available in electronic format, the candidate will submit with the application a copy of the book/monograph of which he/she is the author, the website of the conference where the paper was presented, ISSN, Proceeding etc, or scanned copies in pdf format;

The candidate's professional skills are evaluated by the competition committee based on the competition file and, additionally, through one or more competition tests, including lectures, courses or the like, according to its own methodology. For all positions for an indefinite period, at least one competition test is mandatory represented by a public lecture of at least 45 minutes in which the candidate presents the most significant previous professional results and the university career development plan. This test must also include a question session from the committee and the public. The University announces on the website of the competition the day, time and place of this test, at least 5 working days before the test.

Stages of the competition:

Stage I - the assessment of the candidate's application file (evaluation of the documents in accordance with Methodology for occupying vacant didactic and research positions.

Stage II - Holding a public lecture of minimum 45 minutes where the candidate has to deliver in at least 45 minutes a presentation of his/her most significant professional results as well as plans for the development of his/her academic/scientific career.

g.) Full list of documents that candidates must include in the competition file

a) application for registration in the contest, signed by the candidate, which includes a declaration on own responsibility regarding the veracity of the information presented in the file;

b) a proposal for the development of the candidate's academic career from the didactic point of view and scientific research activities; The proposal is drafted by the candidate, comprises a maximum of 10 pages and is one of the main criteria for distinguishing candidates.

c) curriculum vitae of the candidate in printed and electronic format;

d) list of works of the candidate in printed and electronic format;

e) the verification sheet of the fulfillment of the university's standards for submission to the competition completed and signed by the candidate;

f) documents regarding the possession of the doctoral diploma: certified copy of the doctoral diploma and, if the original doctoral diploma is not recognized in Romania, the certificate of its recognition or equivalence;

g) summary, in Romanian language and in a language of international circulation, of the doctoral thesis or, as the case may be, of the habilitation thesis, on maximum one page for each language;

h) declaration on the candidate's own responsibility indicating the situations of incompatibility provided by Law no. 199/2023 in which they would find themselves in case of winning the contest or the absence of these situations of incompatibility;

i) copies of other diplomas attesting to the candidate's studies;

j) copy of the identity card or, if the candidate does not have an identity card, of the passport or other identity document drawn up for a purpose equivalent to the identity card or passport;

k) if the candidate has changed his/her name, copies of documents certifying the change of name - marriage certificate or proof of name change;

l) maximum 10 publications, patents or other works of the candidate, in electronic format, selected by him and considered to be the most relevant for his own professional achievements.


